DATASETS

- **Correcting Misperceived Gender Norms:** A series of harmonized experiments fielded in Jordan, Egypt and Morocco (n=7,000) to test whether correcting misperceived gender norms may lead to norm change and more gender egalitarian attitudes. Data collected in collaboration with Elizabeth Parker (Yale University), Carolyn Barnett (University of Arizona) and Alexandra Blackman (Cornell University).
- **Gender Stereotypes in Autocracies:** Series of conjoint and vignette experiments embedded in a nationally representative survey in Morocco (n=1800) to investigate the effect of gender stereotypes on citizens’ evaluations of female candidates and politicians. Data collected in collaboration with Carolyn Barnett (University of Arizona) and Alexandra Blackman (Cornell University).
- **Group Gender Composition and Legitimacy:** A three-country survey experiment conducted in Jordan (n=3200), Tunisia (n=1600), and Morocco (n=1600) to discern the effect of group gender composition on mass perceptions of decision legitimacy.
